For a small project, we are looking to import a solar panel (HS Code is 8541.42.00.00) brand directly from the Chinese distributor, however, the anti-dumping policy (SIMA) will add a crazy amount of importing tax, duty (154.4%) and fees (countervailing duty equal to 0.340 Yuan per watt) that will increase the cost of each panel by 3 times!
