The country's Energy Efficiency Law (Law 21.305/2021) aims at reducing energy consumption across the power, transport, buildings and industry sectors, and includes a coal phase-out plan by 2040. In 2022, Chile's Ministry of Energy published an update to its Long-Term Energy Policy (PELP, first published in 2015), which re-emphasises the pledge to net-zero, laying out a clear decarbonisation pathway that addresses all sectors of the national economy. Emphasis is on an integrated policy approach so that a transition can be sustained by the domestic market without.
