According to Aurora Energy Research, solar and wind farms with a combined capacity of nearly 1.2 gigawatts (GW) were operating in Europe in 2023 alongside large-scale battery storage. PV plus battery storage led the way with 724 megawatts (MW), followed by onshore wind. Hybrid solar, combining solar with storage or wind, is key for Europe's energy transition. It supports system flexibility, improves the cost-effectiveness of an asset and makes energy generation more reliable. Hybrid solar projects with storage or wind enhances energy security by ensuring a more. The EU's electricity transition reached a new milestone in 2025 with wind and solar generating more power than fossil fuels. Wind and solar generated a record 30% of EU electricity, higher than fossil power for the first time on record. By integrating complementary technologies within a single facility and grid access point, they maximise renewable energy generation, mitigate intermittency issues, and bolster grid stability.
